1. Health-Related Services Notice with Opt out Response (DOSS)- Joy explained the health related items that pertain to SB 12. She explained how Charter schools were handling the opt out for parents. Ms. Washington stated there have been several questions but no opt out from parents as of today. There have been some questions about mental health and have been directed to school counselors for help.

c. Nurse/Health Updates

1. Campus Vision and Hearing Screenings (District Nurse)- Nurse Washington stated they are currently doing the mandated health screenings through all campuses. There is also a clinic in Red Oak as a resource for parents for screenings by the LIONS club. February is American Heart Month and Nurse Washington would like to celebrate Heart Health throughout the district. Jump Rope for Heart Fundraiser can be used during February. Nurse Washington will check out what resources are available to celebrate and Rachel Ren suggested they tie Heart Health with Kindness week.
